The regularization to the cadre mentioned above is subject to verification of educational qualification certificates submitted by candidate on the basis of which he/she has become eligible for regularization.

Regularization of the above mentioned Daily Wagers is subject to fulfillment of eligibility criteria as per Bank's Service Rules and following terms & conditions:-

- That the past service rendered by the candidate as Daily Wager in the Bank will
  not be counted as regular service in the Bank or towards regular services for any
  service benefits.
- That the candidate will be on probation for a period of two years which may be further extended for one year at the discretion of the Bank as per Bank's Service Rules.
- 3. That the services of the candidate will be governed by the service rules of the Bank as amended from time to time.
- 4. That in case of resignation the candidate shall be required to give three months notice in writing or pay an amount equal to his/her pay for the period of notice to the Bank.
- 5. That the candidate will produce an authentic proof of his date of birth at the time of his joining.
- 6. That the candidate will produce the proof of his educational qualification at the time of joining.
- 7. That the candidate will submit a domicile certificate issued by the competent authority and proof of permanent residence.
- 8. That the candidate will submit attested copy of caste certificate issued by the competent authority, if applicable.
- 9. That the candidate will submit personal data on the prescribed format enclosed.
- 10. That the candidate will produce a medical certificate of his/her physical and mental fitness from Medical Officer of Health Department of Government of H.P. The medical fee shall be borne by the candidate.
- 11. That the candidate will furnish a statement of his/her assets and liabilities including that of his/her spouse and unmarried sons/daughters.
- 12. That the candidate is required to execute the Bank's standard service agreement as enclosed on non-judicial paper of Rs. 100/- at own cost, duly attested.

13. That the candidate will give a declaration that he/she does not have any near relation with any member of the Board of Directors of the Bank before joining in the Bank on the Performa enclosed.

14. That the candidate will furnish an affidavit that he/she will not demand/claim any ex-gratia (renamed as annual incentive in lieu of bonus) from the Bank during the period of entire service in the Bank. However, the candidate will be entitled to bonus as per the payment of Bonus Act depending on the admissibility.

15. Transfer request shall not be entertained before completion of three years. However, Bank reserves the right to order transfers in between on administrative

arounds.

16. That the candidate shall submit declaration regarding maintaining secrecy on

prescribed format.

17. That the candidate shall submit photocopy of this appointment letter duly signed by him/her on each page, as acknowledgement of acceptance of terms & conditions of appointment.

Photocopies of all the certificates should be attested by a Gazetted Officer.

In case above terms and conditions are acceptable, the candidates are required to report for duties in the office of the Bank as mentioned against their names under the column "Place of posting on regularization as Peon" within seven days from the date of issuance of this order, failing which this offer made to the candidate shall stand cancelled without any further notice and it would be presumed that the candidate is no more interested in serving the Bank and his/her services would be terminated and no further correspondence shall be entertained in this behalf.

The Branch Managers/District Managers/In-charges concerned shall ensure timely relieving of all the aforementioned (wherever applicable) enabling them to join at their new place of posting within seven days from the date of issuance of this order.

The employees will be entitled for TTA/DA/JT (wherever applicable) as admissible under Bank's service rules. However, they will first join duties at new place of posting and avail joining time later.
