**(Promotion Orders)**

On the recommendation of the Selecting Authority/DPC of the Bank made in its meeting held on 01.02.2024, approval of BoDs vide resolution No. 40(4) dated 06.02.2024 and subsequent approval by the Registrar Cooperative Societies, H.P. vide letter No. 5-234/99-Coop.(C&M)-X dated 16.02.2024 under Rule 56(3) of H.P. Cooperative Societies, Rules 1971; the Management of the Bank is pleased to issue promotion orders of the following Peons to the post of Daftri in the corresponding pay matrix/level as applicable, with immediate effect, in the order given below. The promotion to the higher grade is on officiating basis and they shall remain on probation on the promoted post for a period of two years in terms of Rule No. 7 (i) read with Rule No.18 of HPSCB Employees (Terms of Employment and Working Conditions) Rules, 1979. They shall be entitled for the benefits of promotion from the date of joining in the promoted grade.

The District Managers/In-charges/Branch Managers concerned shall ensure timely relieving of all the aforementioned employees (wherever applicable) enabling them to join at their new place of posting within seven days from the date of issuance of this order. The employees will be entitled for TTA/DA/JT (wherever applicable) as admissible under Bank's Service Rules. However, they will first join duties at new place of posting and may avail joining time later.

Further, for fixation of pay in the promoted grade, the employees may exercise option within a period of 30 days from the issue of these orders in terms of FRSR-22(C), if they desire so. However, it may be noted that in case option is exercised by some junior and he/she starts drawing more pay than them, the benefit of step up at par with junior will not be admissible.

In case the above employees fail to join in the promoted grade within the stipulated time as given above, the promotion shall be treated as forfeited and such employee shall have no right to claim benefits of promotion / seniority / pay fixation etc. against his / her juniors and his / her name will not be considered for promotion again at least for one year.
